December is the month of full gratitude for the students at Bancroft. We held our annual toy drive in which students and families donated toys to the school. We collected over 120 toys that were given to Shriners hospital so they could be distributed to the patients. In addition to the toys, we also collected over \$700 in gift cards that were provided to ten families. The donations helped them have a little merrier holiday!

The week before winter break, we held our annual Winter Program by the students in grades 1st-3rd. During the school holiday program, the students gathered together on stage to perform a vibrant and heartwarming set of songs. Their voices blended harmoniously, filling the auditorium with energy and joy. The performance was a celebration of community and the magic of the holiday season, leaving everyone with a sense of warmth and togetherness.

Our registration for the 2025-26 school year for Transitional Kindergarten and Kindergarten opened on January 13, 2025. Transitional Kindergarten enrollment is through a lottery. Students who will be four years old by September 1, 2025, can apply for placement. The application window for the lottery is January 13 through February 21, 2025. Students who will be five years old by September 1, 2025, can register now for Kindergarten through the regular registration process. However, spaces are filled on a first-come, first served basis. Once we reach our enrollment capacity, students may be transferred to another school where there is space.

During the day when classes are in session, the neighbors have identified extended periods of time when Citadel Way between Notre Dame Drive and Chestnut Hill Drive are completely blocked and regular traffic and emergency vehicles are unable to pass.

The request is for a study to determine if limited parking along Citadel Way will address and bring a satisfactory resolution to the neighbors' concerns.

Sacramento READS

Two years ago, the SCOE board adopted a resolution making literacy a priority. We were gravely concerned that less than 45% of the students in our county were reading at grade level. We should all be outraged and concerned about this statistic, as the data is even worse for low income and students of color. The resolution directed staff to create an initiative to address this problem. The SCOE launched an effort called Sacramento READS, to ensure every child will be reading at grade level.

The resolution has nine key principles that we encourage school districts to embrace including an emphasis on training teachers and administrators to use the Science of reading research to deliver effective first instruction, encouraging use of interim data to identify and intervene with students who are behind, and ensuring culturally diverse curriculum and parent and family engagement. In partnership with the literacy coalition, SCOE staff, and several board members are approaching school districts, cities, the county, and civic groups to adopt the resolution and make the science of reading and literacy a priority. Not being able to read at grade level leads to behavior problems, students dropping out, inability to attend higher education, and constrains career advancement. Every student deserves the right to read. Please join us in supporting this community wide effort.

Most devastating fires happen in the foothills or mountains, but in Los Angeles we have seen how high winds can create havoc even in the flatlands. The same was true in 2017 in Santa Rosa when high winds pushed a wall of flame over a six-lane freeway and into Coffey Park, a neighborhood not unlike College-Glen.

Behavioral Health Services Expanded

From the Desk of Supervisor Rich Desmond

Sacramento County expanded two Behavioral Health Service programs earlier this year, combining Access and Substance Use Prevention Treatment (SUPT) services to streamline care, address critical needs, and enhance the health and safety of our community.

Behavioral Health Services-Screening and Coordination (BHS-SAC) Call Center

The new BHS-SAC Call Center simplifies access to mental health and substance use treatment services by combining multiple phone numbers into one centralized line: 916-875-1055. The new contact number ensures that individuals in need can receive timely coordination among providers and improve health outcomes for those struggling with mental health and substance use.

Implementation of Senate Bill 43 (SB 43)

Sacramento County will implement the State's modernized law for involuntary psychiatric holds which expands the definition of "gravely disabled." This new definition includes individuals unable to care for their basic needs for health and safety due to a severe substance use disorder or, co-occurring mental health and severe substance use disorders.

SB 43 also broadens the definition of "basic needs" to include a person's ability to obtain necessary medical care, personal safety, food, weather-appropriate clothing, and/or shelter.

This law will expand access to acute and long-term care for our most vulnerable community members who are suffering from a severe substance use disorder.

The efforts implemented reflect the County's dedication to providing comprehensive care and fostering collaboration between health services and community partners.

As Deputy Attorney General, Maggy Krell developed a breakthrough legal theory that dismantled the largest online sex trafficking operation in the nation. She received a career achievement award from the National Center for Missing & Exploited Children for her work helping survivors.

Maggy Krell was recruited by Planned Parenthood as its Chief Legal Counsel to push back against the Trump White House's assault on reproductive freedom.

And Maggy Krell served as a pro-bono lawyer along the border, reuniting mothers and children who had been forcibly separated and detained hundreds of miles apart.

Maggy Krell brings legal scholarship and policy leadership to the California State Assembly.

The 311 Service Center is a seamless and efficient way to connect with the City of Sacramento. 311 is a non-emergency service that gives citizens and visitors multiple channels to connect, report and inquire information about city services; report problems such as potholes, abandoned vehicles, illegal dumping, and more.

Whether it's garbage collection, leaf pickup, street sweeping or world-class drinking water, Sacramento is a leader in providing quality customer services. Sacramento City 311 enhances these amenities by making city government even more accessible. The Sacramento city 311 service center is a centralized contact center for the City of Sacramento that is intended to make life a little easier for its residents, businesses and visitors. 311 works to answer questions as our live representatives are ready to assist you 24 hours a day, seven days a week.

When can I call 311?

The 311 Customer Service Center is open from 7am to 7pm, 7 days a week, 365 days a year. The service center will still accept calls for any after-hours emergencies after 7pm for issues such as animal emergencies, public right of way hazards, utility emergencies, and other critical situations requiring immediate attention. Just dial 3-1-1 or if you're outside the City limits call (916) 808-5011.

Can I use my smart phone or mobile device?

The City of Sacramento's 311 Customer Service portal offers full mobile support. You can also download the Sac311 Mobile App from Google play and the App Store . The mobile app is simple to use, you can also download pictures of the issue so they can better understand how to resolve the issue.

Just remember, the City can't address our neighborhood issues if we don't work together to report what is going on.

Sailor Bar is a secluded area just downstream from the Nimbus Fish Hatchery in Fair Oaks. Visitors from all over Sacramento County and beyond visit for a respite from the business of life. There are 5 parking lots, one that has direct access to the river. Once you park, you can walk for a 3.5-mile loop. Wildlife is flourishing at Sailor Bar. Deer, coyotes, beavers, otters, squirrels, rabbits, turtles, foxes, bobcats, a variety of birds, snakes, and other species of wild animals are thriving in this protected land.

Today, Sailor Bar is one of the few places along the Parkway that is safe and free of trash. Animals can safely reach the river without the threat of traffic. Families, dog walkers, bird watchers, photographers, fishers go to Sailor Bar for the peace of nature.

Sadly, The County is planning to allow public vehicular traffic in the protected interior of Sailor Bar. Together, we can stop it. Find out more:

Lower American River Erosion Project

Welcome to Contract 3B, the portion of the American River Common Features Project (from Howe Ave to Mayhew Drain) planned by the US Army Corps of Engineers (USACE) to armor the riverbanks of the lower American River to prevent erosion. This project is a continuum of the riverbank work already completed in the Campus Commons and CSUS area. Visit americanrivertrees.org to view videos showing the affected project area, the work that has been done, and how it has been done.

We consider it overkill. Instead of armoring the entire riverbank, burying quarried rock along the riverbank, and adding rock revetment along the river's edge, as shown in the previous work, we ask that USACE redesign their approach to this area, using a more focused and nature-based solution for targeted areas most at risk of erosion. Otherwise, we will have a riverbank without existing vegetation and without the beloved myriads of plants, wildlife, birds, mammals, reptiles, and fish. We want few, if any, trees to be removed, as they provide a shading canopy that cools water for young fish and waterfowl, provide shelter and food, and provide natural erosion protection. The old Heritage Oaks (some over 300 years old) are especially essential to our current environment, as they have shown they have unique carbon sequestering abilities and have survived the extreme volumes of water and droughts – especially protective powers during climate change.

To reconstruct this section of the American River Parkway, established in 1959 (23-miles from Natomas to the Sacramento River), would be to disrupt this corridor and its natural environs through an urban area. Also state and federally designated as a Wild and Scenic River and often referred to as "the jewel" of the Sacramento region, this area claims over 8 million visitors a year.

We ask USACE to "Pause, engage the community, and develop alternative designs" for a better, more focused, more appropriate method of preventing erosion on this beautiful stretch of natural paradise. This is more in keeping with the President's acknowledgment of American the Beautiful, the Governor's 30 X 30 Initiative (to save 30% of natural environment by 2030), and the Lower American River Conservancy program to protect and restore the natural resources of this river.

Update from Sacramento Area Creeks Council (SACC)

It has been a minute since you heard from SACC and I thought it might be time to update you on our activities. We had a great 2024 and we are planning for an even better year in 2025! We had a fantastic response to the Big Day of Giving in May, receiving many donations from folks who appreciate the efforts of SACC and our partners: the River City Waterway Alliance, Elk Grove Anti-Trash Volunteers, and Arcade Creek Adopt a Creek volunteers.

Our collective efforts have made a positive impact on the amount of trash throughout the American River Parkway, including on December 26th when 11 volunteers removed 1700 lbs. of trash near Howe Avenue. We staffed exhibits throughout the year with various non-profits and neighborhood groups, handing out fliers and books to kids who play our "trash game." We had a wildly successful Streamside Social fundraiser in October that garnered many sponsorships and donations and brought people together to learn what we are all about. We ended the year with an excellent nominating committee who developed a slate of officers and board members for 2025 that we will be voting on at our next meeting. For the first time in years our Board will be full, with enthusiastic, energized individuals who want to help grow the organization.

Greetings from Your Sacramento Fire Department!

The Sacramento Fire Department finished the year off by responding to over 108,000 calls for service last year with the busiest piece of equipment being Medic 2, located in Downtown Sacramento. This is down from the previous year by around 2,000 calls. We have also introduced a public/ private partnership with Medic Ambulance Company. Medic Ambulance now provides four additional ambulances to our very busy emergency medical system to assist with lower acuity calls. These ambulances are basic life support or BLS units and are available for non-life-threatening emergencies keeping the advanced life support or ALS units available for more critical calls. This is a very welcomed addition to the Sacramento Fire Department. As the needs of our community develop, we must adapt and respond with the appropriate resources. There will be more changes coming up in our emergency services delivery plan. Stay tuned!

As we move forward in 2025, we will be christening a new boat. We just took delivery of a new rescue boat that will be located at Miller Park to serve the Sacramento River and the American River. This new boat has the ability to not only provide for water rescues on the rivers, but it can also flow water for boat fires and other fires along the shorelines. This is a great addition to our marine assets!

Sacramento Police Department Leadership Rotation

The Sacramento Police Department (SPD) has a tradition of periodically rotating its leaders in management positions, so they have the opportunity to see other parts of the organization and become more well-rounded in serving our community. Captain Stephen Moore has overseen the East Command, which includes our neighborhood, for the past two years. Captain Moore has served our neighborhood well by attending our meetings, keeping us informed, and has played a key role in supporting our National Night Out by showcasing SPD's resources and divisions. Thank you, Captain Moore!

On January 4th Captain James Harrington took over as Area Commander. A big welcome to Captain Harrington who attended our January meeting. He shared with us that College Greens holds a special place for him as he has several family members that live right here in our neighborhood. We look forward to working with Captain Harrington to keep our neighborhood safe and informed.

CGNA/Foundation Mail Not Delivered

On October 7, 2024, the CGNA Foundation put into the USPS system 731 pieces of mail. The envelopes were taken to the West Sacramento post office in six trays. We believe 5 of the 6 trays were mailed and received by area residents while the 6th tray with 353 envelopes was never delivered. Three hundred and fifty-three undelivered envelopes were all addressed to residents within the 95826 area of either College-Greens or Glenbrook. The content was a thank you for the 2024 contribution, a 2024 window sticker, and a copy of the agenda for the 2024 Annual Meeting.

We requested the USPS and Congresswoman Doris Matsui's office help locate the tray but have yet to receive a reply. The event has passed and we have been advised that we will probably never get a reply from the USPS or Matusi's office. The Association/Foundation apologizes to those residents that did not receive our letter of appreciation and a window sticker for 2024.

College-Glen Real Estate

The calendar has turned to 2025 and with that brings new predictions for the economy and real estate market. Looking back, 2024 was a slower year for home sales in College-Glen. It was another year defined by interest rates causing not a lot of homes for sale (owners clinging to their 3% mortgages).

On the buyer's side, they appeared to be pretty picky. If it was priced right and updated then it would sell quickly for top dollar, but overpriced and outdated listings sat on the market for prolonged periods. In total, there were 60 homes that sold in the neighborhood. That is significantly lower than the average of 101 homes sold per year from 2018 – 2022. But because of the low supply of homes for sale, that kept pricing stable. Of the 60 homes sold in 2024, the average sales price was \$534,543. The highest sale for the year was \$698,000.

Looking forward to 2025, interest rates will be the wildcard. If they drop into the low 6%s, expect for the market to pick up a bit with both more sellers and buyers. If they continue to hover around 7% then we'll continue to have a similar market to 2024. The market will hinge on which direction interest rates go from here.

CGNA/Foundation's 2024 Annual Meeting Informative and Well Attended

The 2024 Annual Meeting began with light refreshment that included McDonald's McCafé Coffee and Hot Chocolate, and Jason's Double Chocolate Brownies and Mrs. Barudoni's WWII cookies. The meeting included the election and introduction of Association and Foundation officers and corporate financial reports, and a summary of the year's events. This was followed by reports from community organizations, academic guests, and local business and elected representatives as well City and County staff including city police, fire department, and probation department. Neighbors then heard from the candidates for Mayor of Sacramento, State Assembly District 6, and Sacramento City Unified School District Trustee Area 3 followed by a visit from Senator Angelique Ashby and Mayor Darrell Steinberg.

The meeting closed with an open forum question and answer session that included guests and candidates hosted by Councilmember Eric Guerra and SMUD Board Member Gregg Fishman.
